Downhill-Carts – Usage Rules

1) Confirmation of acknowledgment of the usage rules by participation

Before using the downhill carts, each participant has the opportunity to review these uage rules. By participating, the participant tacitly confirms these usage rules..

2) Responsibility

Using the downhill carts involves risks. The carts are accelerated downhill by gravity. The driver must always choose their speed so that they can stop safely at any time. The participant declares to perform several brake tests with both brakes at the beginning of the downhill section. The participant is liable for self-inflicted accidents. In case of multiple accident causers, the participant must consider their contributory negligence within the framework of liability.

For the liability of the company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG, point 5 applies otherwise

3) Minimum age, minimum height

Only persons who do not suffer from an illness, psychological, or physical impairment that could pose a danger to themselves and/or another person while using the downhill carts are allowed to participate.

The downhill track can only be used by participants who are 16 years old and at least 1.60 m tall.

4) Safety instructions

Each participant must keep their feet on the footrests and their hands on the handlebars and brake levers. A mass start is prohibited. Do not leave the lift track and downhill track. Leaving the bullcarts on the downhill track is not allowed. The exit area must be vacated immediately. Brake discs and lines must not be touched. Intentional collisions must be avoided. Helmets are mandatory. All instructions from the organizer are binding and must be followed without fail. In case of violation or non-compliance, the participant can be excluded from using the downhill carts. In the event of intentional or grossly negligent violation or non-compliance with the safety requirements or instructions of the organizer, the participant is responsible for any resulting damages. The consumption of alcohol is prohibited before and during the ride.

5) Limitation of liability

The company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG is liable for personal injuries within the framework of legal regulations. For material and financial damages, liability exists only in cases of intent, gross negligence, or negligent breach of a contractual obligation (cardinal obligation) by the company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG, its representatives, or vicarious agents.

6) Exclusion of the participant, right of domicile, closure in case of force majeure, non-refund of entry fee

The company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG is authorized to exclude persons who do not comply with the usage rules from using the downhill carts. The company exercises the right of domicile and is entitled at any time to stop operations for safety reasons (fire, storm, thunderstorm, etc.).
